GENERAL PRICE LIST

These prices are effective as of **September 2, 2016** and are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead.

If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

“Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.”

MINIMUM SERVICES OF THE FUNERAL DIRECTOR AND STAFF \$ 795.00

This fee for our basic services and overhead will be added to the total cost of funeral arrangements you select. (This fee is included and deeply discounted in our charges for direct cremations, immediate burials and forwarding or receiving the remains).

This fee includes the following:

- ❑ Personnel available 24 hours a day, 365 days a year to respond to initial call
- ❑ Arrangement Conference
- ❑ Coordinating service plans with cemetery, crematory and/or other parties involved in the final disposition of the deceased. *(Important - it is the responsibility of the family/legal next of kin to contact the cemetery of their choice, a separate transaction and business entity from the funeral home).
- ❑ Clerical assistance in the completion of documentation, various forms and permits associated with the disposition of a decedent. Also covers overhead including facility maintenance, equipment, inventory costs, business insurance, workman’s compensation, administrative expenses, State and local licensing and governmental compliance.

TRANSPORTATION:

TRANSFER OF THE DECEASED

Transfer of Deceased from Place of Death or Other Facility. **\$ 295.00**
24 hour attendant (one) and removal vehicle to transfer the deceased within 35 mile radius. Additional distance will be charged at \$6.00 per mile.

Second Attendant for Transfers from Residence or Residential/Assisted Living, etc. *Add....* **\$ 100.00**

Standard Service Vehicle *(Per Vehicle and Driver)* **\$ 250.00**

Suitable Service vehicle and driver used for Funeral and Graveside Services. (And/Or) Utility vehicle for deliveries or transport of floral pieces. Within a 35-mile radius. Additional distance will be charged at \$6.00 per mile.

Traditional Hearse/Coach *(Optional)* **\$ 395.00**

Hearse and Coach Driver for traditional funeral or other services. Charged per service component per day within a 35-mile radius. Additional distance will be charged at \$6.00 per mile.

Transfer To or From Airport **\$ 250.00**

Driver and vehicle to deliver or receive human remains to or from local airport.

Transfer To Crematory or Cemetery **\$ 250.00**

Driver and service/utility vehicle for delivery of remains to local crematory or cemetery.

PREPARATION OF THE BODY:

Except in certain special cases, embalming is not required by law.

Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing.

If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

EMBALMING PROCEDURE, CLEANSING OF REMAINS.....**\$ 475.00**
USE OF PREPARATION FACILITIES.

Beneficial for the temporary preservation, cleansing and holding of remains for viewing services and prior to the dressing of the body with the selected clothing.

REFRIGERATION* / HOLDING FACILITIES.....**\$ 395.00**

Includes up to five days maximum. \$50.00 per day after five days.

***California law requires Funeral Homes to refrigerate an un-embalmed body after 24 hours**

Our services include transfer to the outside facility or church, set-up, coordination of arranged funeral service, staff to assist with the funeral ceremony and floral display followed with immediate accompaniment of remains to cemetery by staff with setup and supervision of concluding local graveside formalities. Equipment and Staff Services for Funeral Service at Graveside Only **\$ 495.00**

Our services include accompaniment of remains to cemetery for a **graveside service** or **delivery of remains at an arranged specific time**, supervision of graveside services and staff to assist with the service. Family to provide capable pallbearers.

Use of Staff for Additional Evening Service **\$ 485.00**

An evening service can be a Vigil, Rosary, Vespers, Prayer or other service and is usually in addition to the primary funeral service the following day.
Staff, setup, assistance and supervision of evening service.
This fee will apply in addition to all other regular fees when our staff is required for a formal evening service. *Additional Weekend Charges Apply – See Additional Charges

Coordination and Staff Services for Memorial Service at Other Facility **\$ 485.00**

Our services include travel to outside/other facility, set-up, assistance with floral display, coordination and supervision of memorial service. (Without body present).

IMMEDIATE BURIAL PACKAGE: **\$ 6495.00 TO \$ 1495.00**

Service Charges for Immediate Burial include: **\$ 1495.00**
Removal of remains, minimal services of staff, documentation, refrigeration holding, casketing (casket purchased separately) and delivery to a local cemetery at a non-specific time. ****No graveside supervision or other formalities/services provided.**

Immediate Burial with Minimum casket **\$ 2240.00**

Immediate Burial with container provided by purchaser **\$ 1495.00**
(All such containers must meet any applicable state or cemetery requirements)

Immediate burial with other casket selected from our facility **\$ 1495.00**
(In addition to the cost of the casket – Please see our Casket Price List)

Immediate Burial with Washing and Dressing of Remains (Plus the cost of the casket) **\$ 1895.00**

Immediate Burial with Graveside Service Formalities or Specific Time of Delivery **\$ 1990.00**
(Does not include cost of casket) Supervision of graveside services and staff to assist with the service. Family to provide capable pallbearers.

Immediate Burial with Washing, Dressing and Graveside Service Formalities **\$ 2390.00**
(Does not include cost of casket) Supervision of graveside services and staff to assist with the service. Family to provide capable pallbearers.

****PLEASE NOTE:**

Immediate Burial is usually selected by families for its lower cost and simpler means of disposition as an alternate choice to cremation. The Immediate Burial Selection is purposely structured for simplicity and lower cost by eliminating funeral service formalities and viewings/visitations. (Many families hold memorial services at another time.)

No changes or substitutions of services are allowed to take advantage of this selection's cost. Delivery, upon completion of documents and necessary permits is done at the convenience of the funeral home and the cemetery. No graveside service supervision is provided unless selected.

FORWARDING REMAINS TO ANOTHER FUNERAL HOME: **\$ 1895.00**

This charge includes the removal of the remains, minimum services of staff necessary documentation, embalming, use of preparation room and transportation to local airport.

This charge does not include: Airline shipping charges, ceremonies of any kind or visitation/viewing, transit permit fees, the cost of a casket, basic shipping container or a special combination shipping unit. *Shipment only within the Continental United States.*

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME: **\$ 1395.00**

This charge includes minimum services of staff, re-filing of documentation. Transportation from local airport. Transportation to cemetery or crematory. **This charge does not include** casketing, visitation, funeral or graveside ceremonies of any kind.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers and other cremation containers, including containers made of wood, containers made of fiberboard and containers made of other composite materials. Please see descriptions below. We also offer a selection of cremation oriented caskets.

DIRECT CREMATION SELECTION:

Our charges for “Direct Cremation” (without ceremonies) include: A Discounted Non-Declinable Basic Service Fee, 24 Hour Response Personnel Transfer of Remains (One Attendant) from place of death or Coroner, Refrigeration/Holding Facilities Documentation, Minimum Services of Staff, Transportation to Crematory.

***Current Crematory fees are separate outside charges and are not included in the following quotes for our services. Crematory fees are required and payable to a State Licensed Crematory for the actual act of cremation and those fees will be added to the services and their associated cost quoted below. Crematory Fees are subject to change without notice now and in the future. Current Crematory fees are quoted with inquiry and upon request.*

Identification Viewing – For I.D. Purposes Only \$ 295.00

Specific time - 30 minutes only, please. Limited number of persons. Three to five people maximum. Private, not an open public visitation or service. Use of facilities, staff, setup, transportation of remains to and from crematory holding facility.

Staff for Witness Cremation or Request for Specific time at Crematory \$ 250.00

Our services include coordination and required supervision at crematory for set-up of witness formalities at an appointed time. **This fee does not include any fees that the Crematory may charge for a witness cremation at a specific appointed time.*

An overtime charge will be made in regards to any and all services, visitations, usages of a facility and/or staff, including transportation personnel dispatched upon ready-to-release notice to transfer a decedent, that are caused to be delayed or extended or concluded beyond the arranged time period and or beyond the reasonable expected amount of time to perform and complete any service or procedure.
